# PLAYER WAIVER FORM

TURN IN THIS FORM AT TOURNAMENT TEAM CHECK IN

The King of the Court— Official Soccer Tennis Tournament requires that every player, and their parent or Guardian- if the player is under age 18- must read this waiver form. Signatures on the registration form signify each person has read, understands and abides by this information.

In connection with any and all King of the Court—Official Soccer-Tennis Tournaments held, sponsored and/or officially presented or endorsed by King of the Court, LLC or Maher Brothers Soccer LLC, a New Jersey limited liability company, the “Player” specified below agrees for the benefit of King of the Court and sporting event venue as follows:

**Liability Waiver.** Player acknowledges and agrees that: (1) Player’s participation in the Event requires extreme feats of a person’s physical and mental limits and carries with it the potential for death, serious injury or property loss; (2) Player expressly assumes the risks of participating in Event with full understanding of such potential risks; (3) Player maintains his own medical, disability and life insurance sufficient in Player’s determination to cover any expenses and damages that Player and his family, including loss of income, arising from Player’s injury, disability or death; (4) Player expressly waives, releases and discharges King of the Court, Maher Brothers Soccer LLC, and sporting event venue from any and all claims, costs, expenses or liabilities (including those involving death, personal injury or property damage) arising out of or relating to my participation in the Event.; (5)Player agrees not to sue King of the Court or Maher Brothers Soccer LLC or sporting event venue for any Claim; (6) Player indemnifies, defends, protects and holds harmless King of the Court and Maher Brothers Soccer LLC and sporting event venue from any Claims; and (7) Player agrees to execute such additional waiver and release as sporting event venue may reasonably require. **On Camera/Photo Release.** King of the Court and Maher Brothers Soccer LLC intends to film/photograph the Event and related events and activities (“Recordings”) in connection with King of the Court and Maher Brothers Soccer LLC production of various films, television programs, DVDs, training film productions, promotional materials and the like (“Productions”) derived from its Events. Player knowingly and voluntarily agrees to be filmed during the Recordings and agrees that King of the Court and Maher Brothers Soccer LLC, its successors and assigns, have the right but not the duty to use Player’s name, voice, likeness and/or biographical information (collectively “Likeness”) in the Recordings and Productions in perpetuity without any compensation, as same may be exploited and exhibited in any and all media, including any advertising of soccer-tennis events, the Productions or King of the Court and Maher Brothers Soccer LLC, and including the right to edit or modify the Recordings. Player acknowledges that the Recordings are the sole and exclusive property of King of the Court and Maher Brothers Soccer LLC, which is entitled to all rights of ownership and all rights of copyright in and to the Recordings and Productions; with King of the Court and Maher Brothers Soccer LLC, owning all of the results and proceeds thereof, in all media, in all perpetuity.

This waiver must be presented at every team check in and will need to be signed BEFORE YOUR TEAM WILL BE ABLE TO PLAY.
